^{• &}quot;DFS" stands for "Daily Fantasy Sports," but is used here to include all formats of paid fantasy sports games/contests (*i.e.*, season-long or daily). Paid fantasy sports games are contests with an entry fee in which participants select virtual teams based on real athletes. The participants and their virtual teams earn points based on the performance of real players in actual athletic events. Examples of paid fantasy sports operators include FanDuel, DraftKings, Yahoo! Sports, and FantasyDraft.

- **Sports betting** is a form of gambling based primarily on chance, in which participants wager on the occurrence (or non-occurrence) or outcome of a specific athletic event or act. Examples of sports betting providers include William Hill Sportsbook, Caesars Sportsbook, 888sport, BetAmerica, FanDuel Sportsbook, and DraftKings Sportsbook. Note that some companies operate in both verticals (*e.g.*, FanDuel and DraftKings), but the universe of DFS operators is larger than that of state-licensed sports betting providers.
- Online casino gambling is used here to refer to traditional betting games normally found in a casino, but which are played in a purely digital, online environment.
